ADVENTURE GOLF RULES

- 3. All players should at all times take care of the golf course. Running and jumping on the equipment is not allowed.
- 4. If anyone wishes to play after hours, they must have pre-approval from the Activities Department.
- 5. Players must follow the course rules on the Adventure Golf Course official score card.
- 6. Anyone not following these rules will be asked to leave the Adventure Golf course.
