Each section of Hilltop Lakes is referred to herein as the "Section ____ Restrictions" where the blank is filled in by the particular section number. The restrictions for Hilltop Lakes are referred to herein collectively as the "Hilltop Lakes Restrictions."

2. Amendment Language.

The Hilltop Lakes Restrictions, with the exception of Sections 15, 16, 33, 75, 76, 88, 89 and 90, are hereby amended by adding the following language (the "Amendment Language"):

Each such maintenance charge, together with interest commencing on the due date at a rate of interest to be set from time to time by the Board of Directors not in excess of the maximum lawful rate, costs of collection, late charges, reasonable attorney's fees and court costs, shall be a charge on the land and

shall be secured by a continuing lien upon the land against which each such maintenance charge is made. Each such maintenance charge, together with interest, costs of collection, late charges, and reasonable attorney's fees and court costs, shall also be the personal obligation of the person who was the Owner of such land at the time the such maintenance charge fell due.

3. Location of the Amendment Language.

The Amendment Language is added to the Restrictions for the separate sections of Hilltop Lakes as follows:

- a. Sections 1, 2, 3A, 3B, 3C, 4, 5, 7 at the end of Paragraph 14.
- b. Sections 33, 75, 76, 88, 89, 90 at the end of Paragraph 30.
- c. Sections 9, 10, 10A, 12A, 12B, 62, 62A, 82, 82A, 86 -- at the end of Paragraph 31.
- d. Sections 16, 60 -- at the end of Article V.
- e. Sections 2A, 3D, 3E, 4A, 6, 6A, 8A, 8C, 8D, 11, 11A, 11B, 13, 23, 24, 24A, 25, 26, 27, 31, 32, 34, 35, 36, 36A, 36B, 36C, 37, 46A, 46B, 47A, 47B, 48A, 48B, 49A, 49B, 50, 50A, 50B, 51, 52, 70, 71, 72, 73, 74, 80, 81, 83, 84, 85, 100, 101, 102, 103, 104, 105, 106, 107, 108, 109, 110, 111, 112, 113, 114, 115, 116, 117, 118 -- at the end of Paragraph 15.
- f. Section 15 at the end of Paragraph 32.

4. Legal Authority for the Amendments.

With the exception of Sections 15, 16, 33, 75, 76, 88, 89 and 90, the Hilltop Lakes Restrictions authorize the officers of the Association to amend the Restrictions as follows:

- c. "from time to time" Sections 37, 50, 100, 101, 102, 103, 104, 105, 106, 107, 108, 109, 110, 111, 112, 113, 114, 115, 116, 117, 24a, 36c, 46a, 46b, 50a, 50b, 51, 52, 60, 73, 74, 47a, 47b, 48a, 48b, 49a, 49b, 70, 71, 72, 80, 81, 83, 84, 85, 118, 9, 10, 62, 82, 86, 10a, 12a, 12b, 62a, 82a.
